
Exports Matter


Office of International Business Development

PA Export Grant Program

GAP (Global Access Program)

- * Assists companies up to \$10K per Federal Fiscal Year to reimburse 75% of eligible expenses associated with specific export promotion activities.
 - > Trade Shows/Missions
 - Meetings with perspective clients overseas
 - Certifications such as ISO's

This program is administered by OIBD and funded in part through the SBA

SBA Office of International Trade

Office of International Trade (OIT) Mission

To increase the number of U.S. small business exporters and increase the volume of U.S. exports; The Office of International Trade works to enhance the ability of small businesses to compete in the global marketplace.



Key Area of Works

Export Finance Managers (EFM)

- Provide local support/trainings to lenders to make and service SBA export guaranty loans
- Process and underwrite Export
 Working Capital Program (EWCP)
 Loan application
- Provide counseling and training to support small business export opportunities
- Help small business exporters gain access to the capital they need



International Payment Terms





SBA Export Loan Programs*

Export Express (EE): (Avg. \$264,200)

- Flexible; can be structured as term loan or line of credit.
- 90% guarantee for loans up to \$350M
- 75% guarantee for loans between \$350M and \$500M

Export Working Capital Program (EWCP): (Avg. \$2.1MM)

- Monitored lines of credit up to \$5MM; 90% guaranty
- Asset-based or Transaction-based structure
- Support for Standby Letters of Credit with 25% collateral
- For experienced exporter with higher working capital needs.

International Trade Loan (ITL): (Avg. \$2MM)

- Term financing up to \$5MM; 90% guaranty
- Used for capital assets, permanent working capital, refi, acquisitions
- For existing exporter or Applicant has realistic plan to become an exporter

FY24' No SBA fees for loans \$1,000M and under



^{*}Permanent 90% guaranty of the Export Loan Programs allow a bank to set aside **only 28% of the capital required** for a conventional loan.

Indirect Exports – applies to all SBA export loans

- Applicants who produce products or services that enter the export channel, but do not directly export their products:
 - Manufacturers using an Export Trading Company
 - Suppliers to other domestic manufacturers that export directly: supply chain financing solution
- Can be supported by all **three** of SBA's core export loan programs: EWCP, Export Express, International Trade Loan



SBA Export Loans provides Solutions

- Loan guaranties, just like the widely used 7(a) and SBA Express loans
 - Same eligibility as other SBA loans
- Highest guaranty available to incentivize the lender 90%
- Flexible structuring
- Competitive Tools for borrowers
